## MEMORANDUM OF LAW IN SUPPORT OF PLAINTIFFS' MOTION FOR DISTRIBUTION OF CLASS ACTION SETTLEMENT FUNDS

Plaintiffs The Berkshire Bank ("Berkshire") and The Government Development Bank of Puerto Rico ("GDB" and together with Berkshire, the "Lender Plaintiffs" or "Plaintiffs"), on behalf of itself and the Settlement Class Members in the above captioned Action, respectfully submits this memorandum of law in support of its Motion for Distribution of Class Action Settlement Funds.<sup>1</sup>

#### I. INTRODUCTION

The Court has entered final judgment approving class action settlements with the following entities: Citibank, N.A., Citigroup Inc., HSBC Bank plc, HSBC Holdings plc, Barclays Bank plc, JPMorgan Chase & Co., JPMorgan Chase Bank. N.A., Bank of America Corporation, Bank of America, N.A., UBS AG, Deutsche Bank AG, Deutsche Bank Securities, Inc., Credit Suisse AG and The Bank of Tokyo-Mitsubishi UFJ, Ltd., n/k/a MUFG Bank, Ltd. *See* ECF Nos. 2777, 3097, 3276, 3445. Plaintiffs' Counsel has been advised by the court-appointed Class Action Claims Administrator, JND Legal Administration ("JND" or "Claims Administrator"), that it has completed processing proofs of claim submitted by those persons who responded to the various notices of settlement and has determined which of those persons are Authorized Claimants. *See* Declaration of Jennifer M. Keough in Support of Motion for Distribution of Class Action Settlement Funds (the "Keough Declaration") ¶2. All that remains to complete the Settlement to the Authorized Claimants. Thus, Plaintiffs' Counsel requests that the Court authorize the distribution of the net Settlement Funds to the Authorized Claimants.

#### II. DETERMINATION OF AUTHORIZED CLAIMS

#### A. Deficient and Ineligible Claims

Pursuant to the various Settlement Agreements and the Court's Final Judgments, the Claims Administrator received a total of 1,929 claim submissions for 685,269 loans. See Keough Declaration ¶¶5, 8.

8. JND reviewed each claim to verify that the claim submission was certified and that the information provided was consistent with the supporting documentation provided. *Id.*, at ¶7. JND implemented a system of claim-level conditions to identify claims that were potentially ineligible, deficient, or duplicative. *Id.* For each claim that was determined to be deficient, JND notified the claimant by mail and/or email that one or more deficiencies had been identified with their claim submission and provided a report that itemized each deficiency. *Id.*, at ¶8. The report also included a deficiency guide with a detailed description of each type of deficiency and what curative action was required. *Id.* Claimants were given 20 calendar days to provide responses in order to cure the deficiencies that had been identified to them. *Id.* JND reviewed and processed all deficiency responses received and worked closely with individual claimants both to address any additional questions they had and to assist them in curing their claim deficiencies. *Id.*, at ¶9.

After completing the claim review process, JND identified 964 claims that were ineligible and that it has recommended for rejection because (i) the claimant did not fit the Class Member definition, (ii) the claimant did not have a recognized loss and/or did not supply sufficient loan information, or (iii) the claim was otherwise deficient in a key aspect (e.g. the Claim Form was not signed). *Id.*, at ¶11(b). Claimants whose claims were determined to be ineligible were provided with notification of this determination and, where applicable, given an opportunity to cure the

deficiencies identified with their claim. *Id.*, at ¶12. To date, none of the 964 ineligible claimants object to or contest JND's determination.  $Id.^2$ 

#### **B.** Properly Documented Claims

Of the 1,929 Proofs of Claims received, JND has determined that 690 are acceptable in whole or in part. *Id.* ¶11(a). The 690 valid claims represent Recognized Losses of \$1,532,073,826.73. *Id.*, at ¶14. While certain of the valid claims were filed late, the Court should accept all late but otherwise valid claims received by JND on or before October 31, 2022, because the untimely filed claims have not caused significant delay to the distribution of the net Settlement Funds to the Settlement Class, or otherwise prejudiced any Authorized Claimant. *Id.*, at ¶6; *see In re "Agent Orange" Product Liability Litig.*, 689 F.Supp. 1250, 1261-63 (E.D.N.Y. 1988) (court permitting the qualifying late claimants and opt-out claimants to participate in the settlement distribution because "[t]he cost to the fund of admitting late claimants and readmitting the opt-out claimants to the class action should be relatively small. No significant administrative costs need be incurred to allow the late claims and opt-out claims."). Plaintiffs respectfully requests that the Court approve the 690 properly documented claims as listed in Exhibit B-1 of the Keough Declaration.

#### **III. DISTRIBUTION OF THE NET SETTLEMENT FUND**

As more fully described in the Keough Declaration at ¶15, the Claims Administrator will conduct an initial distribution to Authorized Claimants.

If there is any balance remaining in the Net Settlement Fund after six months from the date of distribution of the net Settlement Funds, the Claims Administrator shall, if cost-effective, conduct additional distributions until it is determined that further re-distribution is not cost-

effective. Keough Declaration at ¶16. If further re-distribution of the funds remaining in the Net Settlement Fund is not cost-effective, the remaining balance of the Net Settlement Fund shall be distributed pursuant to a method approved by the Court.

#### IV. FEES AND DISBURSEMENTS

JND agreed to be the Claims Administrator in exchange for payment of its fees and expenses. Keough Decl. ¶ 17. Pursuant to orders granting preliminary approval of the Settlements the Court approved fees and expenses for the notice and administration of the Settlements totaling \$1,450,500.00. ECF Nos. 3008, 3024, 3218, 3378. The cost of the administration for this project up to the Initial Distribution of the Net Settlement Fund ("Initial Distribution") is \$1,227,329.01. To date, JND has received payment of \$1,209,941.28. *Id.* Accordingly, there is a total of \$17,387.73 payable to JND. *Id.* The estimated cost of conducting the Initial Distribution is \$26,802.00 (attached hereto as Exhibit C is a copy of JND's estimate to conduct the Initial Distribution). Therefore, the total amount requested to be paid from the Settlement Fund to JND is \$44,189.73, consisting of \$17,387.73 in fees and expenses already incurred and \$26,802.00 in anticipation of the work that will be performed for the Initial Distribution, to satisfy all administration fees and expenses.<sup>3</sup> *Id.* 

#### V. CONCLUSION

Based on the foregoing, Plaintiff respectfully requests that the Court approve and enter the [Proposed] Order concerning distribution of the net Settlement Funds.

## DECLARATION OF JENNIFER M. KEOUGH IN SUPPORT OF MOTION FOR APPROVAL OF DISTRIBUTION PLAN

1. I am the Chief Executive Officer of JND Legal Administration LLC ("JND"). This Declaration is based on my personal knowledge, as well as upon information provided to me by Class Counsel and experienced JND employees and, if called on to do so, I could and would testify competently thereto.

2. JND is serving as the Settlement Administrator in the above-captioned litigation ("Action") for the purposes of administering the settlements approved by the Court in its Final Judgment and Order of Dismissal with Prejudice, Granting Final Approval of Settlement between Lender Plaintiffs, Citibank, N.A., Citigroup Inc., HSBC Bank PLC, and Barclays Bank PLC, dated December 20, 2018, ECF No. 2777; .its Final Judgment and Order of Dismissal with Prejudice Granting Final Approval of Settlement between Lender Plaintiffs, JPMorgan Chase & Co. and DECLARATION OF JENNIFER M. KEOUGH IN SUPPORT OF MOTION FOR APPROVAL OF DISTRIBUTION PLAN - 1

This Declaration is being filed in Support of Plaintiffs' Motion for Approval of Distribution Plan.

#### I. <u>CLAIMS PROCESSING</u>

4. Class Members who wished to receive a settlement payment were required to submit a timely and valid Proof of Claim to JND. In order to be considered timely, claim submissions had to be postmarked no later than the following dates:

- a. November 20, 2018, for the Settlements with Citibank, HSBC, and Barclays ("Initial Settlements");
- b. April 21, 2020, for the Settlements with JPMC, BOA, and UBS ("Second Settlements");
- c. February 8, 2021, for the Settlement with Deutsche Bank ("Third Settlement");
- d. June 8, 2022, for the Settlement withs with Credit Suisse and MUFG ("Fourth Settlements").

5. In response to the notice activities described in my previous Declarations, JND received a total of 1,929 claim submissions, of which 1,467 were submitted in respect of the Initial

Settlements; 390 were submitted in respect of the Second Settlements; 33 were submitted in respect of the Third Settlement, and 39 were submitted in respect of the Fourth Settlements. Claimants that submitted a claim for one settlement were not required to submit another claim for any later settlement(s).

6. Of the 1,929 claims submitted, 116 were filed late. JND recommends that the Court accept all late but otherwise valid claims received by JND on or before October 31, 2022, because the untimely filed claims have not caused significant delay to the distribution of the net Settlement Funds to the Settlement Class, or otherwise prejudiced any Authorized Claimant.

7. Claims submitted by mail were scanned into a dedicated database established for the Settlements together with supporting documentation. Claims submitted electronically were loaded into the database with any supporting documentation submitted. Each claim submission was assigned a unique identifier. Once loaded, JND processed each claim and captured the information provided, including the claimant's name, contact details, and loan information. JND then reviewed each claim to verify that the claim submission was certified and that the information provided was consistent with any supporting documentation provided. JND implemented a system of claim-level conditions to identify claims that were potentially ineligible, deficient, or duplicative, as well as to identify at which stage each claim was submitted.

8. As part of their claim submission, claimants were required to list all interests in loans with interest rates based on U.S. Dollar LIBOR held at any time between August 1, 2007, through May 31, 2010. Based on the claims submitted, a total of 685,269 loans were submitted during the course of the Initial, Second, Third, and Fourth Settlements. JND implemented a system of loan-level flags to identify loan information that was potentially ineligible or for which the loan information provided was insufficient or incomplete. By differentiating between deficiencies at

the loan level and deficiencies at the claim level in this manner, valid claims that include some loans that are determined to be eligible and some that are determined to be deficient or ineligible can still be accepted for valid loans claimed. Flags were applied via programmatic review of the loan data submitted and manual review of the output to ensure that the flags were correctly applied.

#### II. <u>DEFICIENCIES</u>

9. For each claim that was determined to be deficient, JND notified the claimant by mail and/or email that one or more deficiencies had been identified with their claim submission and provided a report that itemized each deficiency. The report also included a deficiency guide with a detailed description of each type of deficiency and what curative action was required. Example deficiency notices are attached hereto as <u>Exhibit A</u>. Claimants were given 20 calendar days to provide responses in order to cure the deficiencies that had been identified to them.

10. JND reviewed and processed all deficiency responses received and worked closely with individual claimants both to address any additional questions they had and to assist them in curing their claim deficiencies. This process was repeated for the Initial, Second, Third, and Fourth Settlements.

#### III. <u>DISPOSITION OF PROOFS OF CLAIM</u>

11. After completing the claim review process, JND determined the following claim status for the 1, 929 claims received:

- a. 690 claims were valid and had a recognized loss pursuant to the calculation methodology described in the Plans of Allocation;
- b. 964 claims were ineligible for one of the following reasons:
  - i. the claimant did not fit the Class Member definition (e.g., entity is not headquarted in the U.S. or U.S. territories, or entity was a borrower or otherwise not eligible to receive interest on the claimed transations.);

- ii. the claimant did not have recognized losses. This includes claimants who did not not supply any loan information, the claimed loans were missing key data necessary to render a calculation, or the data supplied rendered calculation losses of \$0 (e.g., the loans were held outside of the class period.);
- iii. The claim was otherwise deficient in a key aspect (e.g. the Claim Form was not signed.)
- c. 205 claims were duplicative.
- d. 70 claims were withdrawn.

A list of claims and their dispositions is attached hereto as **Exhibits B-1 and B -2**.

12. Claimants whose claims were determined to be ineligible were provided with notification of this determination and, where applicable, given an opportunity to cure the deficiencies identified with their claim. To date, none of the 964 ineligible claimants object to or contest JND's determination.

## IV. CALCULATED LOSS

13. JND consulted with Class Counsel and their experts to create and refine the calculation methodology outlined in the Plans of Distribution and developed a proprietary calculation module to implement this methodology.

14. The 690 valid claims represent total Recognized Losses of \$1,532,073,826.73.

## V. <u>DISTRIBUTION PLAN FOR THE NET SETTLEMENT FUNDS</u>

15. In accordance with the Plans of Distribution, after payment of any estimated taxes and escrow fees, and after adjusting for interest accrued during the Settlement administration, and Administration Costs, JND will effect an initial distribution of the Net Settlement Funds as follows:

(i) for each Authorized Claimant, JND determined the *Pro Rata* Share using the methodology described in Paragraph 5.c of the Plans of Distribution;

- (ii) JND then determined each Authorized Claimant's *Pro Rata* Claim using the methodology described in Paragraph 5.d of the Plans of Distribution and recalculating after eliminating from the initial distribution any Authorized Claimant whose *Pro Rata* Claim calculates to less than the De Minimis Amount stipulated in Paragraph 8 of the Plans of Distribuion.
- (iii) Upon entry of a distribution order, JND will issue Settlement payments by check to those Authorized Claimants who were allocated a distribution amount in the manner described herein. Per the terms of the Settlement, distribution checks will be valid for 180 days. In order to encourage Authorized Claimants to promptly deposit their payments, all checks will bear a notation: "CASH PROMPTLY. VOID AND SUBJECT TO REDISTRIBUTION IF NOT CASHED BY DATE 180 DAYS AFTER ISSUE DATE."

16. If after six (6) months from the date of distribution of the Net Settlement Funds there is a remaining balance, JND will, to the extent logically feasible and economically justifiable, reallocate and issue an additional Settlement payment to those funds among those Authorized Claimants who have cashed their checks.

#### VI. <u>FEES AND DISBURSEMENTS</u>

17. JND agreed to be the Claims Administrator in exchange for payment of its fees and expenses. Class Counsel has received invoices for all of the work JND performed with respect to the provision of notice and administration of the Settlements. Future work will include distributing the Net Settlement Fund to the Authorized Claimants and following up with Authorized Claimants that fail to cash checks. The cost of the administration for this project up to the Initial Distribution

of the Net Settlement Fund ("Initial Distribution") is \$1,227,329.01. To date, JND has received payment of \$1,209,941.28. Accordingly, there is a total of \$17,387.73 payable to JND. The estimated cost of conducting the Initial Distribution is \$26,802.00 (attached hereto as <u>Exhibit C</u> is a copy of JND's estimate to conduct the Initial Distribution). Therefore, the total amount requested from the Settlement Fund is \$44,189.73, consisting of \$17,387.73 in fees and expenses already incurred and \$26,802.00 in anticipation of the work that will be performed for the Initial Distribution, to satisfy all administration fees and expenses.<sup>1</sup>

#### [PROPOSED] ORDER GRANTING PLAINTIFFS' MOTION FOR DISTRIBUTION OF CLASS ACTION SETTLEMENT FUNDS

#### IT IS HEREBY ORDERED THAT:

1. Plaintiffs' Motion for Distribution of Class Action Settlement Funds is GRANTED.

2. The funds that are currently in the Settlement Funds<sup>1</sup> (after deducting any Notice and Administration Cost, Taxes and Tax Expenses) shall be distributed on a *pro rata* basis to the Authorized Claimants identified in Exhibit B-1 to the Declaration of Jennifer M. Keough in Support of Motion for Distribution of Class Action Settlement Funds (the "Keough Declaration"), at the direction of Plaintiffs' Counsel pursuant to the various Settlement Agreements and the Plan of Distribution previously approved by the Court.

3. Any person asserting any rejected or subsequently filed claims for the relevant settlements are finally and forever barred as of October 31, 2022, the date used to finalize the administration based on the Keough Declaration.

4. The Court finds that the administration of the Settlements and proposed distribution of the Settlement Funds comply with the terms of the Stipulations and the Plan of Distribution and that all persons involved in the review, verification, calculation, tabulation, or any other aspect of the processing of the claims submitted herein, or otherwise involved in the administration or taxation of the Settlement Fund or the Net Settlement Fund, including, but not limited to Plaintiffs' Counsel and the Court-appointed Claims Administrator, JND Legal Administration ("JND"), are released and discharged from any and all claims arising out of such involvement, and all Settlement Class Members are barred from making any further claims against the Settlement Funds or the released parties beyond the amount allocated to them pursuant to this Order.

5. The checks for distribution to Authorized Claimants shall bear the notation "DEPOSIT PROMPTLY, VOID AND SUBJECT TO RE-DISTRIBUTION IF NOT NEGOTIATED WITHIN 180 DAYS OF DISTRIBUTION." Plaintiffs' Counsel and JND are authorized to locate and/or contact any Authorized Claimant who has not cashed his, her, or its check within said time.

6. Pursuant to the Plan of Distribution, if any funds remain in the Settlement Funds by reason of uncashed checks or otherwise, then, after JND has made reasonable and diligent efforts to have Settlement Class Members who are entitled to participate in the distribution of the Settlement Funds cash their distribution checks, any balance remaining in the Settlement Funds after six (6) months from the initial distribution (whether by reason of tax refunds uncashed checks or otherwise), Plaintiffs' Counsel, in connection with JND, shall, if feasible and cost-effective make a second distribution to claimants who cashed their checks from the initial distribution and who would receive at least \$10.00. Additional re-distributions may occur thereafter in three (3) month intervals until Plaintiffs' Counsel, in consultation with JND, determines that further re-distribution is not cost-effective.

7. JND's request for payment of: (a) outstanding fees and expenses already incurred in connection with the administration in the amount of \$17,387.73; and (b) its estimate to complete the Initial Distribution in the amount of \$26,802.00, as set forth in paragraph 17 of the Keough Declaration and Exhibit C thereto, is approved.

8. This Court retains jurisdiction over any further application or matter which may arise in connection with this action.
